THE ESTABLISHMENT OF SHRIMP FARMING PROJECT IN DAMB, BALOCHISTAN UNDER PUBLIC-PRIVATE PARTNERSHIP (PPP) ON DFBOT BASIS NATIONAL COMPETITIVE BIDDING

PROJECT BRIEF The Balochistan Public-Private Partnership Authority (BPPPA), in lead of Fisheries Department, Government of Balochistan, is inviting proposal from potential bidders to develop and implement the 'the establishment of shrimp farming' project in Damb, Balochistan under the 'Public-Private Partnership' (PPP) on Design, Finance, Build, Operate, and Transfer (DFBOT) basis. The project aims to engage a Private Sector Entity under Public-Private Partnership (PPP) for a concession period of 21.5 Years (0.5 year for financial close, construction time for the project is 01 year and O&M period is 20 years) over an area of 50 acres. Technical details including the project scope can be obtained in the uploaded Request for Proposals ("RFP") document (Project Documents).

BASIC ELIGIBILITY CRITERIA

- Registration with relevant Tax Authorities.
- The Bidder/Consortium shall have an average annual turnover of PKR 400,000,000/- (Pakistani Rupees Four hundred million Only) for the last three (3) years.
- The Bidder/Consortium must have a net worth of at least PKR 200,000,000/- (Pakistani Rupees Two Hundred Million only).
- The Bidder/Consortium must demonstrate expertise and/or prior experience in 'shrimp farming' or related sectoral project across the value chain.

Bidding Procedure The Bidder will be selected under the Balochistan Public Private Partnership Rules. The Project's procurement shall be conducted in accordance with open competitive bidding using '**Single Stage Two Envelope Procedure**' as per the terms and conditions provided in the RFP. Bidders are requested to submit only one (01) Bid, comprising of one (01) original Technical Proposal, one (01) original Financial Proposal, as well as four (04) hard copies of each, and one (01) soft copy of each (USBs) and other supporting documents (as applicable), and as identified in the RFP.

BID SUBMISSION DATE: The Bids must be submitted latest by January 20, 2026 till 11:00 A.M. PST at the address mentioned below.

BID OPENING DATE: The Technical Proposals will be opened on January 20, 2026 at the address mentioned below at 11:30 A.M. PST.

BID SECURITY: All Bidders are required to furnish a Bid Security (in a separately sealed envelope) equivalent to PKR 16,000,000/- (Pak Rupees Sixteen Million only). **THE BID SECURITY SHALL BE ENCLOSED IN THE 'TECHNICAL PROPOSAL' ENVELOPE.** The Bid Security shall be in the form of a bank guarantee issued by a scheduled bank in Pakistan in favor of the CEO, BPPPA.
